Trademark REGISTRATION

It doesn't matter the activity or service you are providing, but you must protect every aspect of your intellectual property by trademark registration, including the name and logos that stand as trademark. A trademark can be a word, name, symbol, device, heading, label, signature, letter or numeral, or any combination thereof used to distinguish the products and services of one company or individual from others.

Copyright REGISTRATION

Copyright Registration is a part of Intellectual Property & crucial for protecting the original work of any creator/author. Copyright registration is a legal term used to describe protection provided to the authors of "original of authorship" like literary work, Song, Movie or artistic etc. But the copyright can be sold or for traded by his originate creator.

Patent REGISTRATION

A Patent gives its owner the right to prevent others from making, using, importing, or selling the invention without the owner's approval. In other words, a patent protects an invention and grants the owner the exclusive right to use the invention for a similar period.

Industrial DESIGN

An Industrial design may consist of three-dimensional features, such as the shape of an article, or two-dimensional features, such as patterns, lines, or color. Industries are allowed to perform Industrial design registration in Dubai in line with the term & conditions as per the UAE Law. In some countries, industrial designs are protected under Patent Law as "design patent."
